## GENERAL RELEASE AND INDEMNIFICATION

I, the above named participant, agree to participate in the 2009 Yockatomac Trek, a bicycle ride from Washington, DC to McKeesport, PA, beginning June 13, 2009 and ending June 21, 2009. I specifically RELEASE and DISCHARGE, on behalf of myself, my heirs, my personal representatives and assigns, the Allegheny Trail Alliance and the Yockatomac Trek, their affiliates and their agents, representatives, officers, directors, employees, successors, and assigns, members or any affiliate of any person or entity of them, from any and all liability, whether known or unknown, even though that liability may arise in whole or in part out of the negligence, omission, or carelessness on the part of persons or entities mentioned above. I further RELEASE and DISCHARGE the above said entities and persons from any and all actions, causes of action, damages, demands, injuries, and liabilities of any nature, including reasonable attorneys' fees and interest, arising out of or in any manner connected with their involvement with my participation in the above referenced activity. I am a voluntary participant in this event, and in good physical condition. I agree to accept all responsibility for the risks, conditions and hazards which may occur whether known or unknown.
